

APPROXIMATE DISTANCES

Tenbury Wells - 3 miles, Bromyard - 7 1/2 miles.

DIRECTIONS

From Tenbury Wells take the B4214 towards Bromyard for about 3 miles and the land will be found on the left hand side just before the right hand turning for Vine Lane and as indicated by a Nick Champion 'For Sale' board.

SITUATION

The land has frontage to and a field gate directly off the B4214. The land runs down to the Kyre Brook which forms its eastern boundary.

THE LAND – 8.504 Acres –3.441 Hectares

Two level permanent pasture fields with a feeder stream running alongside the southern boundary into the Kyre Brook which forms part of the property and provides a natural water supply as well as fishing.

SERVICES

No mains services are connected to the land. An overhead electricity line crosses over the land and a water main is believed to be within the B4214 (tbv). Purchasers are advised to make their own enquiries about the availability of services.

BASIC PAYMENT SCHEME

The land is registered and eligible for the Basic Payment. Entitlements are available by negotiation. The vendors will retain the 2017 Basic Payment.
