# **TENBURY HOLLY, MISTLETOE, WREATHS & CHRISTMAS TREE SALE 2023**

We shall be holding two auction sales this year on Tuesday 21<sup>st</sup> November and Tuesday 28<sup>th</sup> November of holly, mistletoe, wreaths and Christmas trees at Burford House Garden Centre, Burford, Tenbury Wells, WR15 8HQ.

### Buyer Registration - Proof of ID

Buyers must complete a Buyers Registration form and return it to our office **no later than Friday 17**<sup>th</sup> **November.** by post or by email to info@nickchampion.co.uk

On arrival, buyers must provide proof of ID and collect a bidding number and **pay a £5 registration fee** (proceeds for charity).

### **Payment**

Payment must be made on sale day by cash, or debit card. Cheques will only be accepted from regular buyers and from those buyers who have made prior arrangements. **CREDIT CARDS ARE NOT ACCEPTED.** 

## **Collection**

All purchases must be removed on sale day. Goods left including overnight are entirely at your own risk from the fall of the hammer.

#### **Commissions**

If you are unable to attend a sale and still wish to purchase, then do give us a call before the sale day to make the necessary arrangements for us to bid on your behalf. Collections by carrier can be arranged after sale day subject to carriage and packaging charges.

#### **Sale Times**

Approx. 1500 Wreaths at 10.00am prompt, to be followed by approx. 600 lots of Holly and Mistletoe at about 11.30am and approx. 300 Nordman Fir, Noble Fir, Frazer Fir and Norway Spruce Christmas Trees 4'/8' at about 1.00pm.

### **Directions**

From the Teme River Bridge A456 junction in Tenbury Wells proceed west along the A456 in the direction of Ludlow for 0.75 mile and the turn for Burford House Garden Centre will be found on the left-hand side. Please ensure you comply with the parking signs and with any instructions given by the auctioneer's staff.









#### IMPORTANT NOTICE TO ALL BUYERS

The terms below are which Nick Champion Auctioneers offer holly, mistletoe, wreaths and Christmas trees for sale by public auction on Tuesdays 21<sup>st</sup> & 28<sup>th</sup> November 2023.

- 1. **PAYMENT ON SALE DAY by cash or debit card**. Cheque payments will only be accepted if prior arrangements have been made. **Credit Card payments are not accepted.**
- 2. **ALL BUYERS MUST REGISTER AND COLLECT A BUYER'S NUMBER BEFORE BIDDING.** Buyers must complete a Buyers Registration form and return it to our office by **Friday 17**<sup>th</sup> **November 2023 by post or by email to info@nickchampion.co.uk**
- 3. ALL GOODS BECOME THE RESPONSIBILITY OF THE PURCHASER ON THE FALL OF THE HAMMER. The Auctioneers accept no responsibility for loss or damage to the goods on or after the fall of the hammer. All lots must be cleared from the site on the sale day.
- 4. **RETENTION OF TITLE.** Title in all lots remain vested in Nick Champion until payment in full has been made. In the event of the lots being resold before payment is made the buyer shall hold the proceeds of such sale on trust for Nick Champion Auctioneers.
- 5. **ALL GOODS ARE SOLD AS SEEN.** No claims for misdescription will be entertained by the Auctioneers. The declaration of weights is for guidance purposes only, no guarantee of individual tree quality is given. Buyers will be deemed to bid having inspected the lots prior to sale and satisfied themselves as to the quality/quantity of those lots.
- 6. **CHRISTMAS TREE COUNTS WILL BE GIVEN AT THE TIME OF SALE.** No claims for incorrect counts will be entertained unless first checked and agreed by the Auctioneers staff before pick-up.
- 7. **THE AUCTIONEERS RESERVE THE RIGHT** to regulate the bidding, to lot up as they see fit, to withdraw or consolidate any of the lots.
- 8. BUYERS PREMIUM will be charged at 12% on top of the bid price with a minimum charge of £3 per lot on all lots under the Auctioneers Margin Scheme rules.
- 9. **VAT** will be levied at the standard rate (20%) only on the bid price and buyer's premium of any lots entered by VAT registered vendors.
- 10. PRIVATE SALES Purchasing and collection direct from suppliers is <u>not</u> permitted on site or on the access road. Buyers will be liable to pay the auctioneers £50 if found in breach of this rule without exception and will be barred from attendance at future sales.
- 11. ALL BUYERS ARE DEEMED TO BID on the understanding that they have read and understood these conditions of sale. UPON FAILURE TO COMPLY WITH THE FOREGOING CONDITIONS The seller or his agent shall be at full liberty to re sell the said lot or lots by public or private sale without notice to the buyer and the deficiency, if any together with all expenses attending such re-sale shall be made good by the defaulter at this sale and be recoverable as and for liquidated damages.
