RESERVES: Unless a reserve is entered against an item on a fully completed and signed entry form all items will be considered to be without reserve and sold to the highest bidder. The auctioneers will not take responsibility for any reserves not handed in to the sales office on a fully completed and signed entry form by 1.00pm on Friday 12th JULY.

LOTTING: The auctioneers reserve the right to lot, catalogue and display items in the manner they think fit. Entries must be confined to saleable Items only and the auctioneers reserve the right to refuse any item, even though catalogued if they consider them unsaleable.

DELIVERY: All goods should be delivered to **FINCHERS FARM on Thursday 11th JULY between 10.00am & 4.00pm** and are unloaded entirely at the vendor's risk.

AGENCY: The auctioneers act as agents only and are not responsible for any default by the buyer. They disclaim liability for paying the vendor until they have received settlement from the buyer.

SOLD & UNSOLD LOTS: Are the sole responsibility of the buyer if sold, or the vendor if unsold before and after the hammer has fallen and must be removed within 24 hours of the sale.

COMMISSION: Increments of 15% up to £100, 10% from £101 up to £1000, 7.5% from £1001 to £2500, 5% over £2500. Rates apply per slice per item plus VAT. **There is a minimum commission of £2.00 per lot plus VAT whether sold or unsold and a minimum commission per vendor of £10.00 plus VAT.**

ELECTRICAL GOODS: All electrical items must be accompanied by an Electrical Safety Certificate stating the condition of the item. Any item without such a certificate will either be refused entry or have the plugs and cables removed and be sold as scrap. The auctioneers will sell all electrical items "without warranty" and any recourse regarding electrical items will be to the electrician providing the certificate.
