A gate behind 1 Market Street leads to a green entrance door opening into the communal porch which in turn opens into the communal lobby/stairwell and stairs rise up to the first floor entrance door to Flat 2. From the hall doors open into the open plan kitchen/living room (13'11" x 12'6" MAX) with a kitchen area with a range of wooden base and wall units incorporating a sink/drainage with space for a cooker, undercounter fridge and washing machine, the living area has a store cupboard and a sash window overlooking Market Street. There is a small bedroom (9'2" x 6'2" MAX) and a shower room with a Triton T80si shower, a pedestal basin and wc.

Holding Deposit (per tenancy)	One week's rent. This is to reserve a property.
