#### **ACCOMMODATION**

Communal lobby and stairwell with entrance door on first floor leading into entrance hall. The living room (14'5" x 11'4" MAX) has a sash window with window box for flowers and an archway leading through to the kitchen with wood effect fitted base and wall units incorporating a stainless steel sink/drainer, an integral Beko electric oven, Lamona electric hob with extractor hood over, space for a fridge/freezer, plumbing for a washing machine, and housing the Worcester boiler. The double bedroom (11'1" x 9'4") has a sash window with window box for flowers. The bathroom has a bath with shower mixer taps, a pedestal basin and Sani plus wc.

#### **OUTSIDE**

A path off Church Walk leads to the communal gardens which are mostly laid to lawn with mature shrub and flower borders leading to the communal entrance for the three flats.

# NEW ASSURED SHORTHOLD TENANCIES (ASTs) SIGNED ON OR AFTER 1 JUNE 2019

Holding Deposit (per tenancy)

One week's rent. This is to reserve a property. Please Note: This will be withheld if any relevant person (including any guarantor(s)) withdraw from the tenancy, fail a Right-to-Rent check, provide materially significant false or misleading information, or fail to sign their tenancy agreement (and / or Deed of Guarantee) within 15 calendar days (or other Deadline for Agreement as mutually agreed in writing).

Security Deposit (per tenancy. Rent under £50,000 per year)

Five weeks' rent.

This covers damages or defaults on the part of the tenant during the tenancy.

Security Deposit (per tenancy. Rent of £50,000 or over per year) Six weeks' rent.

This covers damages or defaults on the part of the tenant during the tenancy.

Unpaid Rent

Interest at 3% above the Bank of England Base Rate from Rent Due Date until paid in order to pursue non-payment of rent. Please Note: This will not be levied until the rent is more than 14 days in arrears.

Lost Key(s) or other Security Device(s) Tenants are liable to the actual cost of replacing any lost key(s) or other security device(s). If the loss results in locks needing to be changed, the actual costs of a locksmith, new lock and replacement keys for the tenant, landlord any other persons requiring keys will be charged to the tenant. If extra costs are incurred there will be a charge of £15 per hour (inc. VAT) for the time taken replacing lost key(s) or other security device(s).

Variation of Contract (Tenant's Request)
