ACCOMMODATION

A canopy porch with a part glazed entrance door opens into the sitting room with an electric fire with a decorative wooden surround. The kitchen/diner has a range of light wood effect base and wall units incorporating a stainless steel sink/drain, with an integral Beko oven and hob with a Whirlpool extractor hood over, space for a fridge/freezer and plumbing for a washing machine, and with a part glazed door to the garden.

Stairs from the sitting room rise up to the first floor landing with an airing cupboard housing the Baxi boiler, tank and shelving. The double bedroom has a fitted wardrobe. There is a further single bedroom and the bathroom has a bath with a Triton Enrich shower over, a pedestal basin and wc.

OUTSIDE

A tarmac driveway provides ample parking space for three cars. The enclosed rear garden is mostly laid to lawn with a patio entertaining area adjacent to the property.

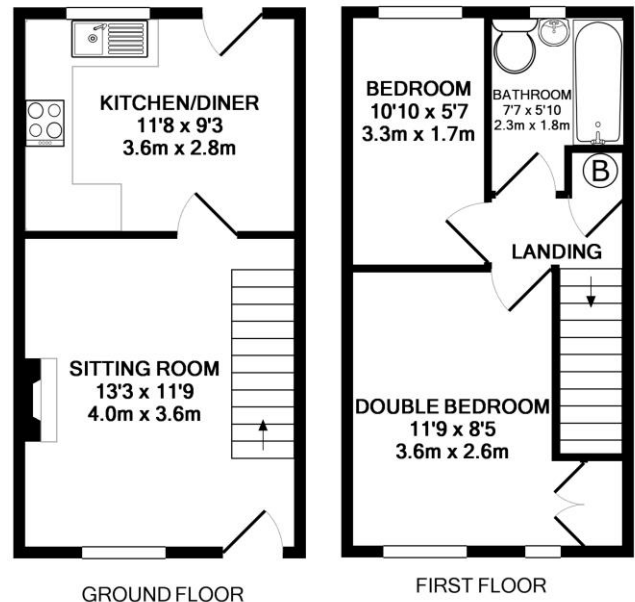

Holding Deposit (per tenancy)	One week's rent. This is to reserve a property. Please Note: This will be withheld if any relevant person (including any guarantor(s)) withdraw from the tenancy, fail a Right-to-Rent check, provide materially significant false or misleading information, or fail to sign their tenancy agreement (and / or Deed of Guarantee) within 15 calendar days (or other Deadline for Agreement as mutually agreed in writing).
Security Deposit (per tenancy. Rent under £50,000 per year)	Five weeks' rent. This covers damages or defaults on the part of the tenant during the tenancy.
