ACCOMMODATION

The kitchen (12'8" x 8'5" MAX) has an oak effect laminate wood floor and newly fitted light grey base units incorporating a stainless steel sink/drainer, a Beko electric fan oven and ceramic hob, plumbing for a washing machine, and space for a fridge/freezer. The living room (16'11" x 15'8" MAX) has a fitted carpet, understairs cupboard and a part glazed door opening onto the garden. The cloakroom has a tiled floor, pedestal basin, wc and cupboard with coat hooks and overhead storage.

Stairs from the living room rise up to the first floor landing with an airing cupboard housing the Megaflo hot water cylinder and shelving. There is a large double bedroom (18' x 12'2") and a second bedroom (10'5" x 8'6"), both with fitted carpets. The bathroom has an oak effect laminate wood floor, a bath with a shower mixer tap, a pedestal basin and wc.

OUTSIDE

A tarmac driveway with parking for up to two cars has an adjacent gravel shrub bed. A wicket gate leads through to the compact enclosed garden with an astroturf 'lawn' and a shrub and flower border.

SERVICES

Mains water, drainage and electricity are connected. Electric night storage heating.
