DIRECTIONS

From Teme Street, Tenbury Wells head north over Teme Bridge and at the Swan Garage T Junction turn left onto the A456 in the direction of Leominster/Shrewsbury. Proceed for 3.4 miles before turning left onto Lynch Lane signed Leysters and after 0.3 mile the stoned drive to Teme Bank will be found on the right hand side.

ACCOMMODATION

The entrance hall has a quarry tiled floor and plumbing for a washing machine. The ground floor shower room has a quarry tiled floor, a Triton Enrich shower, pedestal basin and wc. Stairs from the entrance hall rise up to the first floor open plan kitchen/living room which has a wooden floor, exposed stone walls and timber beams, a range of fitted wooden base units incorporating a stainless steel sink/drain, an integral electric oven and hob, and a Lec undercounter fridge with a freezer compartment. The double bedroom has a fitted carpet and exposed beams.

OUTSIDE

The property has two designated car parking spaces. Visitor parking is also available by arrangement. The property does not have any garden space.

SERVICES

Mains water and electricity.

Oil fired central heating – external Worcester combi boiler.

Shared private drainage.

N.B. The electricity and oil is sub-metered off the Landlord's supply and the Landlord will invoice the Tenant each quarter and at the end of the tenancy for electricity and oil used at the property.

The Landlord will cover the cost of water and drainage for the property, in return the Tenant to pay for the electricity to the adjoining outbuilding retained by the Landlord.

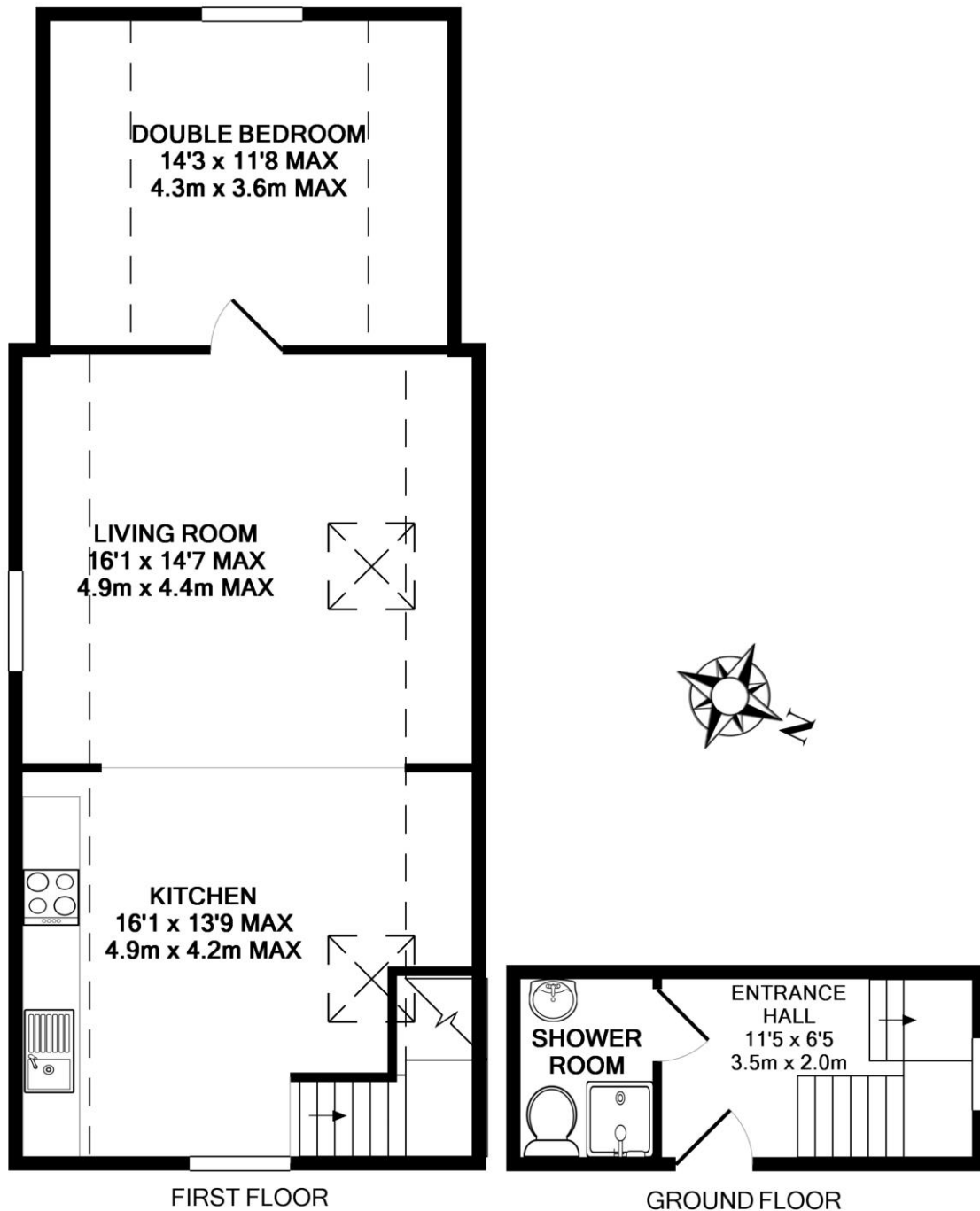

Holding Deposit (per tenancy)

Security Deposit (per tenancy. Rent under £50,000 per year)

Five weeks' rent.

Unpaid Rent
